EXHIBITOR REGULATIONS

- Set up at 8:30AM. Show open from 10:00AM to 4:00PM. Tables MUST remain open during show hours. Tables not set up by 10:00AM will be reassigned or removed. Dealer set-up time will be enforced. NO ADMISSION to show area for any reason by exhibitors before checking in at desk. Name tags received during admission must be worn entering, during set-up and show hours.
- Tables are not transferable. Each exhibitor must register on application form.
- Maximum of two tables per exhibitor.
- Exhibitor's admission included in table charge. One assistant allowed per exhibitor. Assistant pays regular show admission charge. Exceptions will be made for assistants who are members of exhibitor's immediate family. Please indicate assistant's name on application.
- Only photographic related items may be exhibited, traded or sold. NO new currently manufactured photo items may be exhibited, traded or sold, except replicas, toys, photographic souvenirs and items designed, produced and exhibited by established Michigan businesses.
- All items must be priced.
- Shelves on tables are limited in height to five feet above the floor. NO cartons or other objects are permitted in the aisles. No table extensions or auxiliary tables are permitted. No signs or banners over 8 ½ x 11 inches may be displayed.
- The Board of Directors of MiPHS and its Photographica Show & Sale Committee reserves the right to accept or reject applications, to assign tables at its discretion and to make any such arrangements as are necessary to advance the objectives of the Society and promote a well ordered show.
